**The relevance of the topic of dissertation research.** At the present stage of development of society, with the exacerbation of economic, social and environmental problems, it is becoming increasingly important to maintain the health of an individual and society of a particular territory, a whole range of needs appears, the realization of which is provided by the tourism and recreation industry. The formation of socio-economic relations in this industry at the regional level occurs within the framework of the formation and development of regional recreational potential, the use of which is one of the most important tasks, which allows to accelerate the overall regional development, which meets the basic principles of sustainable development of the territory. In the Sugd region, there is an urgent need to implement a set of measures aimed at the effective use of recreational potential and the formation of a system of modern resort and sanatorium complexes that can solve both medical and social problems and the economic problems of forming an industry of tourist and recreational activities in the region. All of the above characterizes the relevance and practical significance of the study of regional recreational potential and the effectiveness of its use in the context of socio-economic development.

**The object of the study is** the totality of organizational and economic relations that are taking shape in the process of formation and development of the recreational sphere of the region.

**The subject of the research is** the recreational potential in the system of factors of socio-economic development of the Sugd region of the Republic of Tajikistan.

**The purpose of the dissertation research is** the generalization and development of theoretical and methodological provisions, as well as the development of practical recommendations aimed at increasing the effective use of the recreational potential of the region in ensuring socio-economic development.

**The scientific novelty of the research results** lies in the development of theoretical principles, as well as the determination of the recreational potential of the region and the development of a set of practical recommendations aimed at increasing the efficiency of using the recreational potential in ensuring the socio-economic development of the Sugd region. In the process of the study, the following results were obtained that determine the scientific novelty and are the subject of protection: an own interpretation of the category "recreational potential of the region" is proposed, the main directions and measures to improve the efficiency of using the recreational potential used by foreign countries are determined, the state of use of the recreational potential of the Sugd region is assessed, factors affecting the rational use of the recreational potential of the region are identified, an algorithm is proposed. It is a summary of the development and effective use of the recreational potential of the region and substantiates the main directions for economic incentives for enterprises of the recreational system of the Sugd region.
